Guidance Notes for Application for Permission for Carriage of Munitions of War in Aircraft

- Note 1: The completed form should be sent to Dangerous Goods Office, Airport Standards Division, Civil Aviation Department, Civil Aviation Department Headquarters, 1 Tung Fai Road, Hong Kong International Airport, Lantau, or fax to 2795 8469. For enquiries, please call 2910 6982 or 2910 6981.
- Note 2: Application form and all supporting document(s) should reach the above-mentioned office at least 11 working days prior to the first flight of which the permission is required.
- Note 3: Application for a long term permission must include the followings:
- i) Procedures adopted by operator to inform the commander of the aircraft in writing before the flight commences about the type, weight or quantity and location of MUW on board aircraft;
 - ii) Procedures adopted by operator to ensure MUW is stored in part of the aircraft that is inaccessible to passengers;
 - iii) Procedures adopted by the operator to ensure all firearms are unloaded; and
 - iv) Procedures adopted by the operator to ensure all ammunitions are securely boxed cartridges for sporting purposes, classified as dangerous goods Division 1.4S in quantities not exceeding 5 kg gross mass per person for that person's own use, excluding ammunition with explosive or incendiary projectiles. Allowances for more than one person must not be combined into one or more packages.
- Note 4: An application fee of HK\$785 for a long term permission or HK\$565 for a single consignment permission is payable at the submission of the application.
