Packing Tips for Air Passenger

<u>Provisions for Dangerous Goods Carried by Passenger</u>

The following information is based on the *Technical Instructions for the Safe Transport of Dangerous Goods* by *Air* issued by the International Civil Aviation Organization (ICAO). It covers some common items that are prohibited to be carried by air passengers, and certain types of dangerous goods items that passengers may carry aboard an aircraft and their related requirements.

Please also note that the carriage of certain items by passengers may require airline's consent. Individual airlines may also have additional requirements on items that passengers may carry aboard an aircraft. If you have any questions, please contact your airline for further information and confirmation before travel.

Note B: - Individual airlines may introduce additional requirements on smart luggage. Passengers are advised to contact their airline concerned before departure should they have any query about the requirements and restrictions applicable to the carriage of smart luggage
