- (a) all broad policy principles concerning Hong Kong civil aviation, including inter alia,
  - (i) the operation and development of the Hong Kong air transport system;
  - (ii) international and regional air transport services; and
  - (iii) legislations required to give support to such policy matters;
- (b) any specific matters concerning civil aviation which may be referred to the Board from time to time by the government for comments and decisions.

### III. 討論事項

委員會於年內召開了三次會議，討論事項包括：

- (i) 飛機噪音管理；
- (ii) 法例和民用航空運輸協定及相關安排；
- (iii) 飛行工作時間限制規條；
- (iv) 香港國際機場的運作；
- (v) 亞太區機場的發展；
- (vi) 衛星通訊、導航及監察／航空交通管理系統；
- (vii) 更換航路監察雷達和改善六項航空交通管理系統；
- (viii) 國際民航組織安全審查；
- (ix) 機場在惡劣天氣下的運作情況；
- (x) 使用酒精及藥物的規管；
- (xi) 香港航空公司機隊擴展和規管要求；
- (xii) 亞太區修訂最低高度間隔操作；
- (xiii) 南中國海飛行空域重劃；以及
- (xiv) 直升機服務的發展。



## III. ITEMS DISCUSSED

The Board met three times during the year. Items discussed included:

- (i) Aircraft noise management;
- (ii) Legislation, Air Services Agreements and related arrangements;
- (iii) Flight Time Limitations;
- (iv) Operation of the Hong Kong International Airport;
- (v) Airport development in the Asia Pacific region;
- (vi) Satellite-based Communications, Navigation, Surveillance/Air Traffic Management (CNS/ATM) Systems;
- (vii) Replacement of route surveillance radar and six air traffic control systems;
- (viii) International Civil Aviation Organization safety oversight audit;
- (ix) Airport operations during adverse weather conditions;
- (x) Regulation on alcohol and drug abuse;
- (xi) Fleet expansion of Hong Kong airlines and regulation requirements;
- (xii) Application of Reduced Vertical Separation Minima in the Asia Pacific region;
- (xiii) Reorganisation of airspace over the South China Sea; and
- (xiv) Development of helicopter services.
