## 負責事宜

航空諮詢委員會就下列事宜向政府提供建 議·

- (甲) 與香港民航業政策原則有關之一切廣 泛問題, 其中包括:
  - (i)香港空運體系之運作與擴展;
  - (ii)國際性和區域性空運服務;及
  - (iii)為實際某些政策而須修定之法制;
- (乙) 政府或會不時向委員會提出特殊之民 航問題, 要求委員提供意見及作出決 定。

#### RESPONSIBILITY

The Aviation Advisory Board is responsible for advising the Government on:

- (a) All broad policy principles concerning Hong Kong civil aviation, including inter alia,
  - (i) The operation and development of the Hong Kong air transport system;
  - (ii) International and regional air transport services; and
  - (iii) Legislations required to give support to such policy matters;
- (b) Any specific matters concerning civil aviation which may be referred to the board from time to time by the Government for comments and decisions.

### **ITEMS DISCUSSED**

The Board met three times during the year. Items discussed included:

- (i) Operation of the Hong Kong International Airport;
- (ii) Airport developments in the region;
- (iii) Logistics development in Hong Kong;
- (iv) Privatisation of the Airport Authority Hong Kong;
- (v) Legislations, Air Services Agreements and related arrangements;
- (vi) Aerodrome licensing of the Hong Kong International Airport to accommodate Airbus A380 aircraft operation;
- (vii) Safe transport of dangerous goods by air;
- (viii) Initiatives to promote quality aircraft maintenance engineers;
- (ix) Installation of radar equipment to enhance Air Traffic Management in the region;
- (x) CAD commitments in search & rescue;
- (xi) Liability for damage caused to persons and property on ground by aircraft;
- (xii) Aviation security activities under the Asia Pacific Economic Cooperation.
