## 個人申請者須知

## **Notes to Individual Applicants**

1. 參觀航空教育徑費用全免,先到先得。

Aviation Education Path visit is free of charge and the date of visit is allocated on a first-come-first-served basis.

2. 個人導賞團逢星期一至五舉行(公眾假期除外)。

Guided tours for individuals are available for booking for visits from Monday to Friday except public holidays.

3. 每團個人導賞團參觀人數以 10 人為上限。

The maximum number of participants for each individual application is 10.

4. 民航處保留更改或取消參觀活動的決定權,導賞團亦可能會與其他導賞團合併,本處將於參觀 前通知參加者。

The CAD reserves the rights to combine, reschedule or cancel the guided tours, and the participants will be informed in advance.

5. 航空教育徑內嚴禁參觀人士以任何形式進行與航空教育徑有關的商業活動,包括但不限於發布商業廣告,或利用航空教育徑的資源牟利。民航處職員如發現此等行為,有權拒絕有關申請、拒絕有關人士入場,或即時中止參觀而無須預先通知。

Trading by visiting individual/s, including but not limited to publication of commercial advertisements or use of the resources of the Aviation Education Path for profit, in any form related to the Aviation Education Path is strictly forbidden in the Aviation Education Path. If such above acts are found, CAD has the right to dismiss the subject application, refuse entry of the individual/s in question or immediately terminate the visit without prior notice.

6. 申請者將收到電郵確認申請成功。

Applicants will receive confirmation by e-mail.

7. 任何人與民航處進行任何事務來往時,均不得向民航處職員提供利益;否則即可能違反《防止 賄賂條例》(香港法例第 201 章)第 4(1)條及/或第 8 條,最高可被判罰款五十萬元及監禁 七年。

Anyone, while having dealings of any kind with the CAD, should not offer advantage to the CAD officers, or else he may commit an offence under section 4(1) and/or section 8 of the Prevention of Bribery Ordinance (Chapter 201 of Laws of Hong Kong), and be liable to a maximum penalty of a fine of \$500,000 and imprisonment for 7 years
