- b) the above documents / information have to be submitted to the Air Services and Safety Management Division (ASMD) by e-filing at <u>https://www.cad.gov.hk/english/efiling_home.html</u>, or where applicable, the System Administrator has to be contacted at <u>asd@cad.gov.hk</u> before making this declaration;
- c) acceptance of the flight plan does not necessarily constitute the approval of the flight application;
- d) this form can only be used in urgent and unforeseen situations on an incidental basis and will not be accepted on a regular basis. The submitted information will be used for record and monitoring purposes. Any abuse of these procedures or operations found not meeting all necessary requirements pertaining to the concerned flights may result in penalty actions; and
- e) it is the obligation of the operator to ensure that slot(s) is / are available before making this declaration.
